James 2:14-17

"What does it profit, my brethren, if someone says he has faith but does not have works? Can faith save him? If a brother or sister is naked and destitute of daily food, and one of you says to them, "Depart in peace, be warmed and filled," but you do not give them the things which are needed for the body, what does it profit? Thus also faith by itself, if it does not have works. is dead."

Case Study

Case 1 – Choosing who to serve

Inja Stees is the ministry leader for the **Serving Others** ministry in the All Nations Church. She has been faithfully serving in the church for many years and has only been recently given this responsibility due to the previous ministry leader stepping down.

The **Serving Others** ministry focuses on helping the community around the All Nations Church which is located in SS71. There are many poor, fatherless, and widows who come from the flats nearby that have benefited from their efforts for the past few years. However, many of them just come to take essentials for their needs but only very few respond to Gospel preaching.

Within a week of her appointment, she decided to cease operations of **Serving Others** in SS71. Instead, she wanted the ministry to focus their attention on the poor, fatherless, and widows in USJ 50.

Injas feels that they are wasting their efforts to help the poor in SS71 since they are not responding to the Gospel despite their continued handouts and support. She feels it is a waste of manpower and funds, which could be channeled to "better areas", where they might possibly respond more positively to the Gospel.

- 2) Discussion question. Was Injas discriminating? If yes, who was she discriminating against?
- 3) a) Discussion question. The Lord Jesus told us to "love our neighbour as ourselves". Was Injas being loving towards her neighbour?
- b) Discussion question. What would constitute a "loving" response for Injas?
- 4) Discussion question. Should Injas still serve the community in SS71 even though they were not responding to the Gospel?
- 5) Discussion question. If you were Injas, what would you do?
