1 Corinthians 11a

Women and Head Covering

Ancient Mediterranean societies existed with an honour shame value system. Within any social group at the time the group's honor before contemporary society depended upon the honor of their patriarch who represented the group. This was the oldest living male like our grand fathers or great grand fathers. But his honor in turn was also dependant upon the honor of the individual group members. Thus in a similar manner a man can be shamed by the dishonoring of the woman as he is responsible for her honor. It was common practice for women to wear head coverings. The coverings gave a sense of respect for the woman otherwise they could be perceived merely as sexual objects or indecent. Not wearing a covering was equivalent to a prostitute wearing their hair down as was common of prostitutes

Thus if they did not wear their head coverings they would bring shame upon their men folk and consequently their whole community.

Others looking in on the fledgling Christian community would immediately notice this and thus the witness of the whole Christian community would be held in shame as far as the society was concerned.

2. What reasons did Paul give that the women had to wear the head coverings?

- e. Emily was asked to go to Bible school and train and come back to the church as one of its pastors what do you think should she do this and under what circumstances should she do this?
- f. Emily trained in Bible college and was now qualified with a Masters in Theology and was asked to teach in one of the classes in the bible school...Can she do this?
- g. Emily was asked to teach the Gamma class of FBC Subang as an invited speaker for three sessions. Can she do this?
